Background/Discussion

The township's anti-virus software licenses expire on March 9, 2013. The attached quote will cover the 14 existing computers in the office. Four (4) new computers will be required soon so that all officials and staff that use BS&A software have the minimum hardware required to utilize the new dot.NET upgrade. Because we have not determined whether or not all the existing computers that will be replaced will stay in service, I would not recommend purchasing new anti-virus software for them at this time. In addition, our new computers may come with anti-virus software so I would not recommend ordering new licenses for them at this time either. If new anti-virus licenses are needed, they can be purchased through Software Express for \$27.50 each. Due to uncertainty in the quantity of licenses needed, I recommend that the Board approve the purchase of anti-virus renewal software for up to 14 computers and also approve the purchase of up to 4 new anti-virus licenses for the new computers with final quantities to be determined by the Executive Committee.
