

Dexter Township Resolution # 17-486

A resolution to set terms for distribution, establish reporting requirements, and appropriate funds to the Dexter Senior Center.

Whereas, the general purpose of the Dexter Senior Center, located at 7720 Ann Arbor Street, Dexter, MI 48130, is to plan, coordinate, evaluate and provide services for the senior population in Dexter and the surrounding townships, and;

Whereas, Public Act 39 of 1976 authorizes monetary contributions from local units of government for such purposes, and;

Whereas, the Dexter Senior Center agrees to provide resources and services to Dexter Township seniors, aged 65 and older, including but not limited to, exercise and enrichment classes, blood pressure screening, hearing aid checks, Medicaid/Medicare assistance, foot care and a food pantry for low income seniors, and;

Whereas, the Dexter Senior Center provided the same aforementioned resources and services to Dexter Township seniors during the 2016-2017 fiscal year, and;

Whereas, the Dexter Township 2017-2018 fiscal year budget has an approved appropriation for the Dexter Senior Center in the amount of \$2,000;

Now therefore be it resolved that the Dexter Township Board approves a grant from the Dexter Township General Fund to the Dexter Senior Center (DSC) of the lesser of \$2,000 or the result of the following equation which shall be calculated using actual data from the period of January 1, 2016 through December 31, 2016:

$$\frac{\text{Total DSC operating budget} \\ (\$54,523)}{\text{Total DSC members over} \\ \text{65 yrs (170)}} \times \text{DSC members over} \\ \text{65 yrs from Dexter} \\ \text{Township (25)} = \$8,018$$

Be it further resolved that the effective date of the total grant is April 1, 2017 through March 31, 2018 and the grant is subject to the following reporting requirements which shall be submitted in writing to the Dexter Township Clerk prior to distribution of monies, noting that the required list of Dexter Township residents who are members of the Dexter Seniors has already been received:

1. Listing of Dexter Senior Center (DSC) programs available to Dexter Township seniors during the grant period;
2. A copy of the DSC financial data used to calculate the maximum allowable appropriation for the fiscal year time period, said data to be signed by the DSC director affirming the accuracy of the data.

Be it further resolved that the Dexter Township Clerk shall, within 10 days of approval of this resolution cause to be published in the newspaper of general circulation notice of the appropriation and terms of the appropriation. This requirement shall be deemed fulfilled with the normally published summary of the March 21, 2017 Township Board meeting.
