- 8) Is the applicant, holder, or premises a law enforcing public official or any member of the Township Board, or any such official who is interested in any way, directly or indirectly, in the manufacture, sale or distribution of alcoholic liquor?
- 9) Is the premises in violation of the applicable Building, Electrical, Mechanical, Plumbing or Fire Codes, Zoning Regulations, or Public Health Regulations, or any Dexter Township Ordinance.
- 10) Does the premises which on the date of application for the license or for renewal have a presently outstanding violation notice from the Michigan Liquor Control Commission.
- 11) Does the premises currently have, or will the premises reasonably soon after commencement of operations have, adequate off-street parking, lighting, refuse disposal facilities, screening, noise, or nuisance control, and otherwise meets, or will meet, the requirements of the Dexter Township Ordinances.
- 12) Is premises, in its proposed location, not detrimental or injurious to the surrounding properties and persons, and/or does it have appropriate provisions for traffic safety, accessibility to the site from abutting roads, capability of abutting roads to accommodate the commercial activity, distance from public or private schools for minors, distance from inconsistent neighboring zoning districts, capacity to control and monitor noise and amplified music, and accessibility from primary roads or state highways.
