



As of January 5, 2016, there were 402 unfinaled permits, some dating as far back as 1997, which had never received a final inspection. By the end of August 2016, there were 36 permits more than a year old that still required a final inspection.

The number of cleared zoning and blight violations does not include those violations that are in the process of being resolved.

There are over 80 unclosed violations that have no record of being resolved. Some of these date as far back as 1999. Following up on these old cases, to determine whether they still constitute a violation, has been a priority of code enforcement with the goal to eliminate all unclosed violations.

## **DIRECTOR OF PLANNING & ZONING NOTES**

Planning and Zoning Intern Erik Perdonik has organized 5 of the 28 zoning file drawers. To date, the pile of duplicate paper removed from the files is 21.5 inches high. His regular schedule concluded on August 22<sup>nd</sup>. He will be able to continue work with the Township on Fridays through the end of the calendar year.

Ordinance Officer Christensen's last day with the Township was on August 22<sup>nd</sup>, which has resulted in both a reduction in code enforcement activity and the lack of fancy maps and charts from this report.

The ordinance officer position has been posted on several websites and shared several places. Staff is conducting interviews with 3 potential candidates and will likely have a recommendation for the Board of Trustees to take action on at its September 20<sup>th</sup> meeting.


