STATE PROPOSAL 2020-1

A proposed constitutional amendment to allow money from oil and gas mining on state-owned lands to continue to be collected in state funds for land protection and creation and maintenance of parks, nature areas, and public recreation facilities, and to describe how money in those state funds can be spent. STATE PROPOSAL 2020-2

A proposed constitutional amendment to require a search warrant in order to access a person's electronic data or electronic communications. YES or NO

WASHTENAW COUNTY PROPOSAL

Proposal to authorize the renewal and restoration of a 0.25 mill for the purpose of purchasing natural areas in order to preserve them, paying the costs of operating a land preservation program and paying the costs of maintaining the land purchased. YES or NO
