**PLEASE TAKE NOTICE** that any qualified elector of Dexter Township who is not already registered, may register to vote at the office of the Township Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at [www.michigan.gov/vote](http://www.michigan.gov/vote) and mailed to the Township Clerk. Voters who are already registered may update their registration at [www.expressSOS.com](http://www.expressSOS.com).

The last day to register in any manner other than in-person with the local clerk is **Monday, October 19, 2020**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the Dexter Township Clerk's office, located at 6880 Dexter Pinckney Road, Dexter, MI 48130 at the following times:

- Regular business hours: Monday, Tuesday, and Thursday from 8:30 a.m. to 4:30 p.m.
- Saturday, October 31, 2020 from 8:00 a.m. to 4:00 p.m. and
- Election Day, Tuesday August 4<sup>th</sup> from 7 a.m. to 8 p.m.


